SACT dataset v3

SACT v3 dataset launched on 1st September 2019 with a 3 month implementation period to 30th November. Trusts should start recording SACT v3 on local systems during this window. Trusts are expected to start uploading SACTv3 files from 1st November 2019. All trusts should be uploading SACT v3 only from 1st February 2020.

Thank you everyone for updating the SACT team on your progress with implementation. If you have not already done so, please ensure you contact the helpdesk if your implementation timelines have changed.

As a reminder, all v3 documents are available on our website www.chemodataset.nhs.uk. Please continue to check the website for the most recent versions.

SACT v3 checklist

Reports on CancerStats2

Report updates

Over the last few weeks, the following reports have now launched or been updated, and are ready to use on CancerStats2 www.cancerstats.ndrs.nhs.uk/

New reports

- ⇒ **Data completeness reports**—presents data completeness for all SACT dataset items. Aims to help trusts identify issues with data quality and completeness
- Haematology reporting suite**—activity data for all haematology patients submitted to the SACT dataset. Split by regimen and outcome level reports. Drug level reports to be launched shortly.
- ⇒ **SACT core targets** (former MO CQUIN reports)- provides SACT data coverage, data submission deadlines, CDF conformance and data completeness for priority data items.

New data

All reports have now been updated and include complete data up until June 2019.

How often will reports be updated and how will I know?

An overview of the SACT CancerStats2 reports and update schedule has now been added to the SACT website <http://www.chemodataset.nhs.uk/reports/>.

These reports will be updated quarterly and an email will be sent to all registered SACT users once new data has been released. This will also be announced on The SACT Dataset Community.

The Cancer Drugs Fund (CDF)

The SACT helpdesk and data liaison team continue to contact trusts regarding missing CDF patients or data items.

The data collection for patients with squamous head and neck cancer receiving **Nivolumab** has now finished. Thank you for continuing to work with us to collect this data. We are delighted to announce that 100% patients who received this treatment were reported to the SACT dataset.

This information has been included in our report to NICE, provides a valuable insight into the real-world treatment outcomes for this drug and will help to inform whether the drug should be available for routine funding in the NHS.

The next drug to exit the CDF will be **Avelumab** for patients being treated for Merkel cell carcinoma. We would be grateful if you could work with the team to ensure data for patients receiving this drug and all other CDF drugs are included in future uploads.

Is age a barrier to systemic anti-cancer therapy?

The National Cancer Registration and Analysis Service (NCRAS) have been working on a paper which has been accepted for publication by **Age and Ageing**. The study - *Is Age a Barrier to Chemotherapy?* - investigates factors that affect the likelihood of older patients receiving systemic anti-cancer therapy (SACT) and their treatment outcomes. This work focuses on patients diagnosed in England between 2013-2015 with stage II-III breast cancer, stage III colon cancer and stage IIIB-IV non-small cell lung cancer (NSCLC), where clinical guidelines recommend SACT. Analyses have been risk-adjusted to account for variation in a range of factors, including patients' age, sex, performance status and comorbidities and are reported at trust level.

We will be in contact with all trusts in the next few weeks to share the results of the study before publication.

The SACT Dataset Community
